The Champlin City Council met in Regular Session and was called to order by Mayor ArMand Nelson at 7:00 p.m.

Special Presentations Hoppoin County Sho

Update from Hennepin County Sheriff Rich Stanek Hennepin County Sheriff Rich Stanek presented an update on the activity of Hennepin County Sheriff's Office and the cooperative efforts between his office and the Champlin Police Department. He provided background information on his career, noting that this is his third term as the Hennepin County Sheriff. He provided demographics on Hennepin County, which includes 1,200,000 people in 45 municipalities and one unorganized territory and 37 law enforcement agencies. He reviewed the leadership of the Sheriff's Office and the eight lines of business that the office is responsible for which include jail, court security, patrol, warrants, civil process, 911/dispatch, crime lab and investigations. He noted that in comparison, the Champlin Police Department handles two lines of business and the Sheriff's Office provided the other six lines of business for the City and also provides backup for the two lines provided by the City.

Councilmember Miller stated that the Mississippi River is important to this community and asked for additional information on the water patrol that is done by the Sheriff's Office.

Sheriff Stanek provided additional details noting that water patrol is provided for the Mississippi River and many other bodies of water throughout the County. He noted that proactive services are provided

Page 1 of 3 Champlin City Council 2-22-16 on the waterways as well as search and rescue services noting that 10 full-time officers are assigned to water patrol in addition to 35 volunteers, which are the equivalent to Reserves in Champlin. He provided details on adult detention/jail services provided by the Sheriff's Office. He provided a brief update on the activities with the different lines of business the Sheriff's Office handles including enforcement services division, patrol unit and special operations unit; water patrol; warrants and civil process; 911 emergency communications, highlighting that the new facility opened about one year ago; crime lab; and the Criminal Information and Sharing Analysis (CISA) Unit.

Councilmember Johnson asked if the CISA Unit was established following 9/11.

Sheriff Stanek stated that in part that arose following 9/11 but noted that the advancement in available technologies has also brought around the establishment of these units.

Councilmember Miller thanked Sheriff Stanek and his department for the outstanding service they provide to the County.

Councilmember Miller stated that the City of Brooklyn Park has decided to use body cameras and asked the Sherriff's opinion on body cameras and whether they intend to use the technology.

Sheriff Stanek noted that there are about 30 agencies in Minnesota that use, or are planning to use, the technology. He stated that he would not support the use of body cameras until the State legislature can create adequate privacy protection for those people receiving services (i.e. a medical call), as the current privacy law are not clear on the policy for protecting that data.

Mayor Nelson thanked Sheriff Stanek for the report and commended him on the service provided by his office.

He provided additional information on the different assessments for this project which include commercial properties, single family residential and multi-family residential.
