Special Presentations

Overview of Worksession Discussion

The City Administrator provided an overview of the discussion that occurred earlier in the evening at the Council Worksession regarding potential opportunities to keep chickens in residential areas. He reported that the Council had a lengthy discussion and decided not to move in that direction at this time. He advised that the Council also discussed the City Council meeting voting procedures and process and decided not to amend the process at this time.

Motion by Councilmember Miller and seconded by Councilmember Karasek to appoint Kara Tarry as the Representative and Bret Heitkamp as the Alternate to the Anoka County Fire Protection Council. Voting in favor were Mayor Nelson, Councilmembers Johnson, Karasek, Miller and Terry. Voting against: none. Motion carried.

Open Forum

Geri Nelson, League of Women Voters ABC, stated that the organization has been studying the plight of pollinators and their project this year is to improve pollinator habitat. She hoped that citizens would band together to help with this dire situation. She advised that a public meeting was held the previous spring and also noted that a forum had been taped recently by QCTV, which is currently airing on cable television.

Ms. Nelson stated that the next step in their process was to bring this matter forward to the member cities in the League of Women Voters, ABC area. She advised that the Champlin group, titled "Bee Friendly Champlin" has met twice.

Ms. Nelson stated that they encourage the planting of pollinator friendly plants and they discourage the use of pesticides. She reviewed the methods of communication the group will be using and advised that the Task Force also plans to meet with the Champlin Environmental Resources Commission and Parks and Recreation Commission. In addition they will be meeting with the Champlin Historical Society and area schools. She stated that 80 percent of plants depend on pollinators and advised that one out of three bites of the typical dinner is also dependent on pollinators. She encouraged others to join the movement and be part of the solution.

Dick Brown, 701 East Hayden Lake Road, stated that he is a member of the Bee Friendly Champlin task force as well as other groups within the City. He stated that he is also a member of the Isaac Walton League of America, which is a national conservation group and advised that group is also very interested in this issue. He provided examples of pollinators, which include different types of bees, butterflies, flies and others. He referenced legislative efforts to establish a 50 foot boundary for bodies of water such as lakes and rivers and believed that native planting should occur in those areas. He also discouraged the use of neonicotinoids. He thanked Ms. Nelson for creating this task force and bringing together all of the parties involved in the issue.

Gina Magnuson, 10232 Hilltop Court, stated that she is present to support native plantings. She stated that she is also in support of allowing residents to raise bees in residential areas. She referenced a University of Minnesota professor that is gaining national attention for her work on pollinators. She provided an example of how plantings could be used to buffer domestic bees. She hoped that the Council would consider not only the native plantings but also allowing bee keeping.

Mr. Brown stated that he did not mention domestic bees because they fall into a different category. He explained that is considered more of a commercial use and described the different efforts that are needed to keep bees. He stated that native pollinators are especially important because they do not require additional efforts and simply need a habitat.

Response to Monitoring Access to Galloway Park The City Administrator stated that Mr. Dan Hanson came forward at the January 12th meeting with a concern over vandalism at Galloway Park and made an offer to open and close the park on a daily basis. He reported that a system has been set up for this resident to assist with opening and closing the park. He stated
